Keith Rosewaren enlisted in the United States Army as a Cavalry Scout in 1978. After completing Basic Training, Advanced Individual Training, and Basic Airborne School he was assigned to C Troop, 1st Squadron, 17th Air Cavalry, 82nd Airborne Division Fort Bragg, North Carolina. While in the unit Keith served as a rifleman, team leader, and troop operations NCO. In 1983 he was assigned to HHC 82nd Airborne Division as a jumpmaster instructor at the 18th Airborne Corp Advanced Airborne School. In 1984 Keith was assigned to C Company USAARMC in Fort Knox, Kentucky as an instructor for the Bradley Combat Fighting Vehicle Transition Course.

Keith was honorably discharged from active duty service in April 1985. After a twelve-year break in service he joined the Missouri Army National Guard in 1997 and was assigned to the 635th Military Intelligence Battalion. In 2002 he transferred to the US Army Reserve and was assigned to the 493rd Military Police Detachment (CDI) as a Special Agent for the US Army Criminal Investigations Command (JSACIDC). In 2003



Keith deployed to Iraq and was attached to the 733rd Military Police Battalion (CID) in support of Operation Iraqi Freedom. He was mobilized to Fort Belvoir, Virginia in 2005 in support of Operation Enduring Freedom and was assigned to Headquarters, G-3 section (USACIDC). In 2008 Keith deployed to Afghanistan and was attached to the 481st MP Detachment (CID) 10th Military Police Battalion (ABN), Bagram Airfield, in support of Operation Enduring Freedom. After twenty-one years of service Keith retired as a Sergeant First Class from the Army in 2011.

Awards and medals Keith earned while in service of his country are as follows: Bronze Star, Meritorious Service Medal, Army Commendation Medal (4th Award), Army Achievement Medal (2nd Award), Good Conduct Medal (2nd Award), National Defense Service Medal, Armed Forces Reserve Medal w/M device (3rd Award), Afghanistan Campaign Medal w/campaign star, Iraq campaign Medal 2/campaign star, NATO Medal, NCO Professional Development Ribbon w/No 3 device, Army Service Ribbon, Army Reserve Component Ribbon, Overseas Service Ribbon, Master Parachutist Badge, and Canadian Parachutist Badge.

In civilian life, Keith joined the Police Department in 1986 and is currently assigned to the Criminal Investigations Unit where he holds the rank of Detective. During his 25 years with the Department he has completed assignments to include Patrol Division, Drug Enforcement Unit, Traffic Safety Unit, and the Special Response Team.

Keith married Linda Mayes and together they have four children: Jessica McNamara, Lucas McNamara, Daniel Logston and Jessica Rosewaren Cain. They have two grandchildren, Andrew and Elizsabeth.
